TO: All persons interested in winter storage at the Clark County Fairgrounds

RE: Timetable and conditions for storage

Clark County will again offer vehicle storage opportunities at the Fairgrounds for this winter. Storage is on first come – first serve basis. **New this year, all gates will be locked with no admittance beyond the staging area off of Rock Road prior to 8:00 a.m. on Saturday, November 3, 2018.** At the staging area storage customers will be directed to the appropriate building for the size of their item to be stored. Storage pull-in will continue until approximately 11:00 a.m. (Storage pull-out is scheduled for April 6, 2019 at 8:00 a.m. for all items.) Please note, overnight parking prior to pull-in is prohibited and any vehicle left unattended will be subject to towing and related fees. On a limited case by case basis, early or late storage pull-in will be evaluated by the Forestry and Parks office and may be subject to additional fees.

Enclosed is a contract for storage. Please make additional copies as needed (one for each item to be stored) and bring the completed form(s) and appropriate payment for submission on the date of storage pull-in. If a copy is desired for your records, please make it before you arrive since we will not have the capability to make copies on the date of storage pull-in.

Items being stored will be measured from “nose to tail” including any hitches or extensions protruding beyond the stored item. Storage fees are as follows with checks to be made payable to the Clark County Treasurer:

- Items less than 20 feet in length – \$100.00 for Nov. 3, 2018 to Apr. 6, 2019.
- Items 20 to 30 feet long – \$150.00 for Nov. 3, 2018 to Apr. 6, 2019.
- Items greater than 30 feet in length – \$200.00 for Nov. 3, 2018 to Apr. 6, 2019.

All fees and forms will be collected at the pull-in event.

WITNESSED, That the said party of the first part, in consideration of the rents and covenants, hereinafter mentioned does hereby Demise, Lease and Let unto the said party of the second part, and the said party of the second part does hereby hire and take from the said party of the first part, the following described premises, situated in the County of Clark, and the State of Wisconsin via one of the following places of storage at the Clark County Fairgrounds: Jr. Dairy Barn (N. side Bldg. 26); Jr. Dairy Barn (Middle Bldg. 26); Jr. Dairy Barn (S. side Bldg. 26); Rabbit Barn (Bldg. 27); Open Class Dairy (Bldg. 28); Goat/Sheep Barn (Bldg. 25); Entertainment Center (Bldg. 4); Quanset (Bldg. 2); or Men's Club (Bldg. 9).

TO HAVE AND HOLD, The above rented premises unto the said Lessee, heirs and assigns, for and during the term from the **3rd day of November, 2018** until the **6th day of April, 2019**. And the said Lessee agrees to and with the said Lessor to pay as rent for the above mentioned premises the sum of _____ dollars as full payment for term of this lease due at the commencement of this lease.

That the Lessee shall hold harmless Clark County, its agents and representatives from any liability for any damage for any cause whatsoever to said Lessee's property or belongings stored or located upon the premises leased from Clark County and the Lessee shall defend Clark County in any such claim.

That the Lessee, shall maintain sufficient insurance on all personal property which Lessee so deems appropriate. That said insurance is the only recourse for recapture of loss. Lessee is solely responsible for insuring its own property.



Clark County assumes no responsibility for damages to any property stored. Lessee has by signing, acknowledged inspecting the premises and finds them safe and adequate as is for the storage of Lessee's property.

That the Lessor does not grant permission to the Lessee to sublet the above rented premises or parts thereof.

And the said Lessee also covenant and agrees to and with the said Lessor not to assign this Lease without first obtaining the written consent of the said Lessor, and that Lessee will, at the expiration of the time herein recited, quietly yield and surrender the aforesaid premises to the said Lessor heirs and assigns, in as good condition and repair as when Lessee took them, reasonable wear and tear and damage by the elements alone accepted.

And the said Lessee agrees that the purpose of this indenture is to facilitate long-term storage. That stored vehicles may not be available for intermittent pull-in and pull-out. The extra costs incurred for early or late pull-out or showing of any vehicle for sale, will be at Lessee's expense.
